### 04 First Aid Measures

**Eye Contact:** Check for and remove any contact lenses. Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical attention if symptoms persist.

**Skin Contact:** In case of contact, immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse. Get medical attention if irritation persists.

**Inhalation:** Move exposed person to fresh air. Flush mouth and nasal passages with water repeatedly. Get medical attention if symptoms persist.
